- a. Three Lakes: Music Crawl went well despite last minute changes due to a band canceling. Oktoberfest is a week from Saturday and continues to grow every year. Annual Awards are in October. Needs more lodging in Three Lakes and more flexibility on bookings. Short-term rental letter request to the county still has not generated a response. Would like the OCTC to reissue the letter with minor adjustments. Hoping to see a new hotel come in to help fill the lack of lodging in the Three Lakes area.
- b. Rhinelander: Visitor center going through renovations. Project North Festival is September 20-21.
- c. Minocqua: Golf outing (Let's Scramble) was last week. Beef- A- Rama is the last weekend in September. 99 vendors in the craft show. 35 roasters this year. Next year is the 60th. Considering a building move to downtown, still discussing with the board of directors. Has applied for grant funding to build an experience center for the 30,000+ visitors who come through their doors each year. In the process of awarding room tax grants. Arbor Vitae, Woodruff, Hazelhurst room tax saw an increase this summer and Minocqua flatlined.
